TOWN BOARD MONTHLY MEETING**

March 15, 2017,

MINUTES

- I. Call To Order and Verification of Meeting Duly Noticed.** Town Chair Dirk Zylman called the meeting to order at 6:30 p.m. at the Mosel Town Hall, W982 County Road FF, Sheboygan. Other Town officials present were Supervisor Dave Wagner, Supervisor Aaron Anger, and Clerk/Treasurer Sue Born, and town resident Ron Roehl. Also present were Lee and Nancy Sixel. Clerk/Treasurer confirmed the meeting was properly posted, March 10, 2017 at the Town Hall at 7:00 p.m. and Website at 7:10 p.m.

- III. Approve/Accept Minutes from February 15, 2017 Town Board Meeting.** Motion Wagner/Anger to accept minutes from February 15, 2017 Town Board Meeting: Motion Carried 3-0.

- A. Discuss and Possible Action on Plan Commissions Land Division Recommendations on the Petition to Divide and Rezone Parcel #59014-185540 Located on Rangeline Road.** The Town Board received the Plan Commissions recommendation to divide a 54.12 acre parcel # 59014-185540 located on Rangeline Road owned by Ronald Roehl into a 3 acre parcel and a 51.12 acre parcel and both parcels will stay zoned A-T.
- Motion Anger/Wagner to accept Plan Commissions recommendation to split the 54.12 parcel # 59014-185540 located on Rangeline Road owned by Ronald Roehl into a 3 acre parcel and a 51.12 parcel: Motion Carried 3-0.
- Motion Anger/Wagner to amend the Plan Commission recommendation to rezone the 3 acres being created from the 54.12 acre parcel # 59014-185540 located on Rangeline Road owned by Ronald Roehl to B-1; Motion Carried 3-0.
- Motion Anger/Wagner to accept the amended recommendation to rezone the 3 acres being created from the 54.12 acre parcel #59014-185540 located on Rangeline Road owned by Ronald Roehl to B-1; Motion Carried 3-0
- Ronald Roehl, the owner of the 54.12 acres has no desire to sell any other lots south of his driveway on Rangeline Road.
